## Definition of Nunavik Inuit Enterprise pursuant to "An Agreement Respecting the Implementation of the James Bay & Northern Quebec Agreement" **For Federal Procurement in Nunavik**

### **Share Capital Corporation**

At least 51 % of the company's voting shares must be beneficially owned by one or more Inuit JBNQA Beneficiaries "or"

a subsidiary of such share-capital corporation, at least 51 % of the subsidiary's voting shares are owned by: (a) such share-capital corporation "or"

by (b) a non-share capital corporation, at least 51 % of the voting members are Inuit JBNQA Beneficiaries.

### **Non-Share Capital Corporation**

At least 51 % of the voting members must be Inuit JBNQA Beneficiaries.

### **Cooperative**

The majority of voting members must be Inuit JBNQA Beneficiaries.

### **Partnership Joint Venture**

A partnership, joint venture or consortium, at least 50 % of which is owned by Inuit JBNQA Beneficiaries.

### **Sole Proprietorship**

Proprietor must be an Inuit JBNQA Beneficiary.

## Definition of Nunavik Inuit Enterprise pursuant to the "Nunavik Inuit Land Claims Agreement" (NILCA) **For Federal Procurement in the Nunavik Marine Region**

### **Share Capital Corporation**

A majority of the voting shares are beneficially owned by one (1) or more Inuit JBNQA Beneficiaries. "or"

a share-capital corporation, a majority of whose voting shares are beneficially owned by Inuit JBNQA Beneficiaries (b) a partnership, including a joint venture partnership, at least 50 % of which is owned by Inuit JBNQA Beneficiaries or (c) a co-operative or non-share capital corporation, a majority of whose voting members are Inuit JBNQA Beneficiaries.

### **Non-Share Capital Corporation**

A majority of the voting members must be Inuit JBNQA Beneficiaries.

### **Cooperative**

A majority of the voting members must be Inuit JBNQA Beneficiaries.

### **Partnership Joint Venture**

A partnership, including a joint venture partnership, at least fifty percent of which is owned by one (1) or more Inuit JBNQA Beneficiaries.

## Definition of Nunavik Inuit Enterprise for the Nunavik Nickel Project **Canadian Royalties**

### Share Capital Corporation

A share-capital corporation, a majority of whose voting shares are beneficially owned by one or more Inuit JBNQA Beneficiaries, "or"

a share-capital corporation, a majority of whose voting shares are owned by either (a) a cooperative or non share-capital corporation, a majority of whose voting members are Nunavik Inuit (b) a share-capital corporation, a majority of whose voting shares are beneficially owned by Inuit JBNQA Beneficiaries "or"

an Inuit Designated Enterprise (an enterprise in which Makivik and/or one or more landholding corporations have a financial interest and designated pursuant to a special provision of the agreement)

### Non-Share Capital Corporation

A majority of the voting members must be Inuit JBNQA Beneficiaries.

### Cooperative

A majority of the voting members must be Inuit JBNQA Beneficiaries.

### Partnership Joint Venture

A partnership, including a joint venture partnership, at least fifty percent of which is owned by one or more Inuit JBNQA Beneficiaries.

## Definition of Inuit Enterprise pursuant to the "The Raglan Agreement"

**(Xstrata)**

### Share Capital Corporation

A share-capital corporation, a majority of whose voting shares are beneficially owned by one or more Inuit JBNQA Beneficiaries, "or"

a share-capital corporation, a majority of whose voting shares are owned either (a) a partnership, including a joint venture partnership, at least fifty percent of which is owned by one or more Inuit JBNQA Beneficiaries, (b) a co-operative or non-share-capital corporation, a majority of whose voting members are Nunavik Inuit or (c) a share-capital corporation, a majority of whose voting shares are beneficially owned by Inuit JBNQA Beneficiaries.

### Non-Share Capital Corporation

A non-share-capital corporation, a majority of whose voting members are Inuit JBNQA Beneficiaries.

### Cooperative

A co-operative, a majority of whose members are Inuit JBNQA Beneficiaries.

### Partnership Joint Venture

A partnership, including a joint venture partnership, at least fifty percent of which is owned by one or more Inuit JBNQA Beneficiaries.
